Dear Valued Customer,

Pacer Stacktrain will make the following changes to our Pacer Expedited door-to-door and rampto-ramp schedules and FAK rate structure as a result of market changes:

SERVICE ELIMINATION:

Effective September 17, 2007, Pacer Expedited service will be eliminated between Baltimore, MD/Los Angeles (Hobart), CA and Baltimore, MD/San Bernardino, CA.

FAK RATES UPDATE:

Effective immediately, FAK rates for service between Los Angeles (Hobart), CA/Memphis (Harvard), AR will change as a result of the terminal change announced in Stack Facts #873 dated May 18, 2007.

Effective September 17, 2007, the FAK rate for service originating in Stockton, CA with the destination of Dallas (Alliance), TX will be reduced.

Effective October 1, 2007, the FAK rate for service originating in Dallas (Alliance), TX with the destination of Stockton, CA will be increased.
