RE: Load Layover for Pending Gate Reservations / 48 Hours Free Time

Dear Valued Customer,

Pacer Stacktrain is pleased to offer Load Layover service – 48 hours free time – to help you manage rail ramp storage costs while securing gate reservations in California outbound markets.

Pacer Stacktrain Load Layover allows you the option of bringing loads awaiting gate reservations to our container yard (CY) locations located in Los Angeles, CA and Lathrop/Stockton, CA.

All loads must have proper rail billing in place before containers are in-gated at the CY for Load Layover. Only loads rail-billed with origins of Lathrop/Stockton, East Los Angeles, LATC and City of Industry will be accepted.

The loaded equipment may be stored for 48 hours of free time. Whenever free time includes a Saturday, Sunday or Holiday, such Saturday, Sunday or Holiday shall count as an additional free day. After the free time expires, storage charges of \$25 per day (including weekends and Holidays) will be assessed. Upon in-gate, the Pacer Stacktrain per diem clock will be stopped, and will remain stopped while your container remains in our CY.

To move your container into one of our CYs, contact Gate Reservation to make arrangements. Hazardous materials loads will not be accepted.

Once arrangements are cleared with Gate Reservations, simply direct your drayman to in-gate at the designated Load Layover location. Upon arrival, the unit will be inspected and secured. When your confirmed gate reservation is available, complete and fax the attached Release and Authorization Form to your Load Layover location to authorize your respective container(s) to be picked up by your drayman. For a drayman to move a container out of our CY, he must have a copy of the signed Release and Authorization Form.
