Announcing New BNSF 53' Service Between Birmingham, AL and California, Effective May 5, 2008

Dear Valued Customer,

In an effort to better serve you, Pacer Stacktrain is continuing to add new service origins and destinations on the BNSF rail network. We are pleased to announce that effective May 5, 2008, we will be offering service between Birmingham, AL and Southern and Northern California. This COFC service is for 53' 110" equipment only (53' 107" and 48' equipment will not be supported). Should the incorrect size of equipment be utilized, the customer will be responsible to cover additional charges such as: draying in a 53' 107 chassis, flips, transloading into 53' 110" equipment prior to shipment, etc. Empty containers are to be picked up at and returned to the container yards (not at the BNSF ramps). Ramp-to-ramp pricing, cut-offs and available day and available times are provided below:
