## **Updated Rules and Procedures Now Available**

Dear Valued Customer:

Pacer Stacktrain has updated its Rules & Procedures. The revisions include:

- Updates to cover the recently published changes to the BNSF Rules & Policies Guide. As previously noted in Stack Facts Bulletin #1049, BNSF issued a new version of its Rules & Policies Guide, which included among other changes a reduction in its cargo liability from \$250,000 to \$200,000 per shipment and an increase in the minimum cargo claims amount from \$250 to \$500. Most of the changes to the Stacktrain Rules & Procedures are intended to address these changes and other provisions of the BNSF Rules & Policies Guide.
- · Addition of excerpts from the BNSF Rules & Policies Guide on prohibited and restricted commodities.
- Updates to cover changes to the cargo liability limits for consumer electronics shipments moving on CSX Intermodal. Like the Union Pacific Railroad, CSX Intermodal has reduced its cargo liability cap to \$100,000 per container or trailer for consumer electronics shipments unless specific security and other procedures are met.
- Changes to Sections 1.2.6 and 13.1.6 as a result of recent legal decisions to address our customers' authori
  zation to bind and obligation to cause the beneficial cargo owner, consignee, consignor, dray carrier and others
  involved in the shipment to comply with the Stacktrain Rules & Procedures and the intermodal circulars of the
  participating carriers; and
- Other clarifications regarding shipping instructions for Mexico shipments.

We are changing the format of this update. Previously we have posted a redlined version of the Stacktrain Rules & Procedures showing changes in the text. For ease of reference, we are instead including a list of the changed sections at the end of the Stacktrain Rules & Procedures.

If the revisions in the updated Rules and Procedures are not already in effect by operational practice or if the effective date is not stated in the updated Rules and Procedures, the changes shown will become effective as of August 4, 2008.
