ICTF DOMESTIC VOLUME TRANSITION

Dear Pacer Stacktrain Customer:

In the continuing effort to provide you and your customers a more consistent and reliable transportation product, we have reached agreement with Union Pacific Railroad to move our Domestic volume from the ICTF in Long Beach to other UPRR facilities in the Los Angeles Basin.

This positive revision concerns Domestic (any box size) volume only and is effective April 15, 2002. International volume will continue to be supported at the ICTF.

The transition involves revised gate cutoffs and terminals as outlined below:
