This service enables IMC's to offer truck/rail/truck, door-to-door delivery of general merchandise freight to Mexico.

congestion at the border.

3. Pacer processes the in-bond permit at Laredo, TX as part of the service.
4. Pacer Stacktrain will provide containers and chassis.
5. USD100,000 cargo liability insurance while freight is in possession of TFM. All claims must be filed with TFM.

**PacerMex NonStop Northeast service excludes:**

1. Mexico Value Added Taxes (IVA)
2. Mexico import duties and brokerage fees
3. Origin/Destination drayage
