In an effort to continually identify ways to provide seamless services in the Southbound Mexico Market, Pacer Stacktrain is pleased to announce our new PacerMex OneStop Service.

PacerMex OneStop product has been designed to service freight from the Midwest, Ohio Valley, Northeast and Southeast to Mexico via rail and allowing for customs clearance to still be executed at the U.S. / Mexico border of Laredo, TX.

Intermodal Marketing Companies utilizing this service send rail billing from origin ramp point to final destination ramp point. We handle the rest. No additional handling by the IMC's at the border. We have it covered. One Bill! One Service! One Contact!

PacerMex OneStop Product Features:

In our new service we control the cross border process in-order to make it as effortless as possible to you the IMC.

We work directly with your broker
We dray to the broker for clearance upon arrival to Laredo, TX (Port Laredo)
We dray from the broker to Nuevo Laredo ramp
We rail to final destination

PacerMex OneStop offers service to two rail destinations in the Mexico City Metropolitan area which are Cuautitlan and Toluca.

This service will be effective Monday, October 25, 2004.

Note: In order to utilize this particular service, there is a specific billing process that must take place to ensure efficient cross border execution.

To move a shipment via PacerMex OneStop, the following steps need to occur:

- When rail billing shipments, the correct PSQ number and suffix must be used. Example to rail bill a FAK shipment, 1000XM is the PSQ number and Suffix. The “M” qualifies the load as a PacerMex OneStop shipment.
- As indicated above, Cuautitlan and Toluca are two destination ramps that this product services. When sending rail billing, the three letter code to indicate which ramp you require is as XUO for Cuautitlan and TLU for Toluca.
- Customs Broker information is needed when sending rail billing.
