

July 29, 2005 Electronic Bulletin No. 685 Re: Reminder - Major changes for routings involving Chicago and the West Coast

Dear Valued Customer:

As previously announced in Stack Facts #678 on June 24, the Pacer Stacktrain network will undergo significant adjustments in the next few days, primarily due to modifications at the Union Pacific Railroad, associated with the UPRR's "Unified Plan." These modifications will involve pickup and delivery ramp locations in both Chicago and on the West Coast, beginning after cutoffs on July 29 for eastbound from Northern California, July 30 for eastbound from Southern California, and July 31 for westbound shipments from/through Chicago. Key details:

## (From or through Chicago) to West Coast – effective after cutoffs on July 31

- Global 1 will support domestic big-box containers (48 & 53) only.
- Global 2 will support ISO/small-box containers (20, 40 & 45) only.
- Global 3 / Rochelle will continue to support all equipment types consistent with service offerings at this location.
- Likewise, destination West Coast terminals change as described below.

LA Basin to/through Chicago – effective after cutoffs on July 30

- UPLA / East LA / Los Angeles will support domestic big-box containers (48 & 53) only.
- City of Industry will support domestic big-box containers (48 & 53) only.
- ICTF / Long Beach will support ISO/small-box containers (20, 40 & 45) only.
- LATC will have no changes and continue to support all equipment types.
- Likewise, destination Chicago terminals change as described in the "Chicago to West Coast" section above.

Northern California to/through Chicago – effective after cutoffs on July 29

- Lathrop / Stockton will support domestic big-box containers (48 & 53) only.
- Oakland will support ISO/small-box containers (20, 40 & 45) only.
- Sacramento will support 48 and 53 domestic big-box containers only.
- Likewise, destination Chicago terminals change as described in the "Chicago to West Coast" section above.

**Pacific Northwest to/through Chicago** – No terminal changes in PNW. Destination terminals change as described in the "Chicago to West Coast" section above.

In general, after cutoffs on July 30, all eastbound containers billed to Chicago and beyond will be destined to or interchanged through the terminals specified above. After cutoffs on July 31, all westbound containers destined to California and billed from Chicago or points in Eastern Canada, the Midwest, or Northeast will be destined to or interchanged through the terminals specified above.

**These modifications primarily affect pickup and delivery locations for routes operating between Chicago and California or the Pacific Northwest**. This also affects equipment that interchanges through Chicago going to/from California/PNW; specifically loads moving to/from California/PNW to/from Ohio Valley points, Eastern Canada, and the Northeast U.S.

These modifications do NOT affect routes that originate or terminate in Denver, St. Louis, Kansas City, Memphis, New Orleans, Mesquite (Dallas), Dolton/Yardcenter, Laredo, El Paso, or Council Bluffs (Omaha), to the extent that those routes do not interchange through Chicago. Also, these changes do not affect the origin or destination ramps in the Northeast U.S. or the Southeast U.S. where Pacer Stacktrain utilizes the CSX network.

The UPRR will protect old environment traffic billed prior to cutover. So prior to the August 1 westbound start date, containers tendered to the CSX for westbound movement through Chicago will be protected by the UPRR to the original destination ramp. For example, a 40' load tendered to CSX Harrisburg on July 29 for Stockton, arrives Chicago on August 2, the UPRR will ship the container to Stockton based on the July 29, pre-Unified Plan ingate date.

The attached table outlines these modifications. These modifications will create some minor adjustments in ramp cutoff and availability times, and those specific changes will be communicated soon. Also, an FAQ on these modifications will be available in the News section of our website at www.pacerstack.com.

Other important points to note include:

- North/South service lanes of the UPRR are not affected at this time. For example, Chicago to/from Dallas is not affected.
- South/West service lanes of the UPRR are not affected at this time. For example, Dallas to/from Los Angeles is not affected.
- Pickup and delivery points in the Northeast U.S. and the Southeast U.S. are not affected at this time.
- Pacer Stacktrain container yards are not affected at this time. The general rule of returning equipment to its point of origin applies. However, if you have any doubt as to where to pickup or return equipment, please contact Customer Support:
