Re: Clarification of Process for Origin Load Layover for Pending Gate Reservations

Dear Valued Customer:

Pacer Stacktrain recently introduced the Load Layover option for Pending Gate Reservations, as announced in Stack Facts #712. We have had several questions from customers about how this program works, and we would like to clarify the details of the process.

All loads must have proper rail billing in place <u>before</u> containers are ingated at the container yard (CY) for Load Layover. Only loads rail-billed with origins of Stockton-Lathrop, East Los Angeles, LATC, and City of Industry will be accepted. We apologize, but Hazardous Materials loads can <u>not</u> be accepted for this program.

Once a load is successfully ingated, the Pacer Stacktrain per diem clock will be stopped, and it will remain stopped while the container is on our CY. In order to keep our CYs fluid we will allow 48 hours storage free time for each container. If the initial 48 hour free time period is scheduled to end on a Saturday or Sunday, free time will be extended until the CY opens on Monday. After the expiration of free time, a \$25 per day storage charge will be assessed for any part of a calendar day where the load is held at our CY, including weekends.

Please be advised that placing a load at the CY for outbound storage is not a request for a gate reservation, and it does not guarantee that a reservation will be granted. IMCs must still secure a gate reservation for the load following the normal process. When your confirmed gate reservation is available for a particular container or containers, simply fill out the attached release form and fax it to the CY where your container is waiting. Our CY staff will release the container to your specified drayman. A pickup number is not required.
